From East: I-94 to exit 175 (Ann Arbor Saline Rd) Turn left (south) on Ann Arbor Saline Rd continue until it ends at Wagner Rd (approx. 2.5 miles) Turn right on Wagner Rd continue to Ellsworth Rd (approx ½ mile). Turn left on Ellsworth Northfield Dog Training is the first driveway on your right.

From West: I-94 to exit 175 (Ann Arbor Saline Rd) Turn right (south) on Ann Arbor Saline Rd continue until it ends at Wagner Rd (approx. 2.5 miles) Turn right on Wagner Rd continue to Ellsworth Rd (approx ½ mile). Turn left on Ellsworth Northfield Dog Training is the first driveway on your right.
