(you will go past the Meijer's on your left and Target shopping center on your right) and proceed until it dead-ends at Wagner Rd. (approximately 2.5 miles). Turn right on Wagner Rd. Go 1/2 mile to Ellsworth Rd., and turn left...first driveway on the right

From the west: take I-94 to exit 169 (Zeeb Rd.). Go south on Zeeb Rd. to Scio-Church Rd. (a four-way stop; approximately 2 miles). Turn left on Scio-Church Rd. to Wagner Rd. (approximately 2 miles). Turn right on Wagner to Ellsworth Rd. (approximately 2 miles). Turn right on Ellsworth...first driveway on the right.

HOW TO USE THIS ENTRY FORM:

- All entries must be submitted on the current "Official UKC® Entry Form". You may use one entry form to enter the same dog in more than one activity on the same weekend.
- Use a separate entry form for each dog entered in a club's event.
- Dog not UKC registered? Apply for a Temporary Listing Number (TL) online at www.ukcdogs.com or call the Dog Events Department at (269) 343-9020. (TL fees are non-refundable, non-transferable and do not apply to the cost of permanent registration.)
- Mail all completed entry forms to the Event Secretary listed under the event, unless otherwise specified.
- Obedience Trials, Agility Trials, Rally Obedience Trials, Weight Pull events and Dog Sport Trial events are open to all UKC recognized breeds and mixed-breed dogs with a valid Limited Privilege number.
- Obedience only: Check the box provided to request either the Veteran or Special Jump height option. Veteran dogs must be 8 years or older. Eligible dogs for Special Jump Heights are outlined in the current rules and regulations.
- Conformation classes consist of: Puppy (6 mos., under 1 yr.); Junior (1 yr., under 2 yrs.); Senior (2 yrs., under 3 yrs.); Adult (3 yrs. and up); Breeder/Handler (6 mos. and up, handled by breeder or member of breeder's family); Champion; and Grand Champion.
- Junior Showmanship classes consist of: Pee Wee (over 2 yrs., under 4 yrs.); Sub-Junior (4 yrs., under 8 yrs.); Novice Junior, Open Junior (8 yrs., under 13 yrs.); Novice Senior, Open Senior (13 yrs., under 18 yrs.)

We want you to keep the points earned at UKC Licensed events. Important things to remember.

- All dogs entering UKC events must be permanently registered, have a valid Temporary Listing Number, or a Limited Privilege number.
- All entry forms must be completed and signed. Incorrect information submitted on the entry form may invalidate your wins.
- To be eligible to enter into the Breeder/Handler class, you must be one of the breeders of record, or a member of the immediate family of one of the breeders of record. Immediate family includes: spouse, parent, step-parent, child, step-child, brother or sister.

WAIVER

All events are held under the Official Rules and Regulations of the United Kennel Club, Inc. Absolutely no alcoholic beverages, illegal drugs or firearms will be allowed on the grounds or in the buildings on the day of a UKC Licensed event. UKC, its agents and employees, and the host club assume no responsibility for any loss, damage, or injury sustained by spectators or by exhibitors and handlers, or to any of their dogs or property, and further assume no responsibility for injury to children not under the control of their parents or guardians. UKC and the host club are not responsible for loss, accidents or theft.

By signing this form, I hereby agree to waive any claim, action, or lawsuit and further agree to indemnify and hold UKC, the host club and any approved UKC Judge harmless from any claims, actions or lawsuits resulting from my participation in this event, and any action, decision or judgment made by any UKC or host club representative or approved Judge under the official UKC Rules and Regulations governing this event. I acknowledge that the current Official UKC Rules and Regulations (Agility, Conformation, Dog Sport, Junior Showmanship, Obedience, Terrier Race, Weight Pull) have been made available to me, and that I am familiar with their contents. My signature indicates that I understand and agree to the above and to abide by all of the current Official UKC Rules and Regulations.
